

GENERAL TERMS AND CONDITIONS OF HIRE

- The final quote is subject to a site survey by qualified ANDREWS SYKES CLIMATE RENTAL engineers.
- Fuel supply to be arranged by Customer (unless otherwise agreed) and must be of a fuel type and grade that adhere to ASTM D-975 specifications.
- If the technical specification of the Fuel provided by the Customer on the site of the Customer's Project and to the Supplier's Equipment does not meet the minimum Fuel Specification ANDREWS SYKES CLIMATE RENTAL will not be held liable. A copy of the ASTM D-975 is available upon request.
- All the civil work is the Customer's responsibility.
- It is the Customers responsibility to arrange any special permits / approvals, scaffolding for access.
- ANDREWS SYKES CLIMATE RENTAL is not liable for any consequential loss or damage of any sort.
- A minimum term of hire period is applicable.
- Payment is strictly 30-days from the date of invoice, unless otherwise agreed in writing. Payment should be made to Andrews Sykes Climate Rental.
- The Hirer's obligation to pay the Hire Rates is unconditional. When the Hirer is responsible for the supply of diesel fuel, the obligation to pay the Hire Rates will remain unconditional.
- The Hire Period commences on the date that the Hire Plant is delivered to Site and terminates on the date that the Hire Plant is returned to ANDREWS SYKES CLIMATE RENTAL.
- Should the Hirer wish to extend the Hire Contract, notification in writing should be provided to ANDREWS SYKES CLIMATE RENTAL at least 7 days prior to end of the initial Hire Period.
- ANDREWS SYKES CLIMATE RENTAL cannot guarantee the continued availability of the Hire Plant.
- Unless otherwise stated, off-hire notices and Hire Contract termination notices should be received by ANDREWS SYKES CLIMATE RENTAL by email at least 7 working days from the intended off-hire date when applicable. Notifications through text/WhatsApp are not accepted.
- Suitable access for trailers and cranes will be required at Site for the duration of the Hire Period and the lay down area must be level and compact.
- The Hirer is required to provide adequate space at Site for ventilation, and at no time should any objects be placed on or in close proximity to the Hire Plant, which could cause a reduction of the air circulation.
- The Hirer will render all reasonable assistance to the ANDREWS SYKES CLIMATE RENTAL Personnel at the Site at their own cost. The Hirer is to provide details of their designated representative(s) who shall co-ordinate the activities between ANDREWS SYKES CLIMATE RENTAL, the Hirer, and any sub-contractors. ANDREWS SYKES CLIMATE RENTAL may require a Site consultation with the representative prior to the Hire Plant being delivered to Site.
- The installation, commissioning and de-commissioning of the Hire Plant will be conducted according to the ANDREWS SYKES CLIMATE RENTAL standard procedures. Where the Hirer requests any deviations, ANDREWS SYKES CLIMATE RENTAL will review the changes and provide a proposal to the Hirer accordingly and ANDREWS SYKES CLIMATE RENTAL will continue with the works upon the Hirer's confirmation.
- The Hirer shall conduct daily system checks of the Hire Plant.

SYKES SILT AWAY ANDREWS

- For the duration of the Hire Period, routine maintenance is carried out by ANDREWS SYKES CLIMATE RENTAL qualified service technicians. ANDREWS SYKES CLIMATE RENTAL may appoint approved service providers for Sites in remote locations.
- The Hirer will be responsible for the cost of all repairs to the Hire Plant, which occurs as a result of the Hirer's negligence or misuse.
- Client accepts any deviation to scope of works which is quoted for may be subject to additional charges.
- Unless otherwise stated, the Hirer is responsible for providing all necessary permits and other local authority approvals, which may include, but not limited to, road permits, police clearance, border fees and clearances, and any Government authorizations required for (SEWA, DEWA etc).
- When applicable, the Hirer shall supply diesel fuel for the Hire Plant of a grade and type specified by ANDREWS SYKES CLIMATE RENTAL. The ANDREWS SYKES CLIMATE RENTAL Fuel Specifications are available on request.
- Receipt of the Hire Plant by the Hirer implies their full understanding and acceptance of the ANDREWS SYKES CLIMATE RENTAL Standard Terms and Conditions of Hire, a copy of which is available on request.
- Any additional works required, which are not explicitly included in the quotation, shall be the responsibility of the Hirer. ANDREWS SYKES CLIMATE RENTAL may provide additional services at an additional price.
- Unless otherwise agreed, all lifting facilities (cranes) of an appropriate capacity for the Hire Plant are to be arranged by the Hirer.
- The Hirer accepts that any delays caused by the Hirer, their subcontractors or end users, in any planned and agreed off loading/loading times of the Hire Plant at/from the Site will result in additional charges.
- Should excessive usage of fuel filters occur because of the Hirer supplying diesel fuel to the Hire Plant which does not satisfy the ANDREWS SYKES CLIMATE RENTAL Fuel Specifications, ANDREWS SYKES CLIMATE RENTAL reserve the right to charge the Hirer for "above normal" filter charges. Any other component damage caused by the Hirer's fuel supply, including without limitation fuel pumps and injectors, will be chargeable to the Hirer at full replacement cost and labour.
- Servicing and routine maintenance scheduled on the Hirer's request outside of working hours, during weekends and public holidays are not included in the Hire Rates and shall be charged in addition to the Hirer.
- Site security is the absolute responsibility of the Hirer. Site security means the safeguarding of the Site and the Hire Plant against sabotage, theft, arson, or any other dishonest or criminal act by physical means, this may include without limitation the installation of security guards, fencing or lighting.
- ANDREWS SYKES CLIMATE RENTAL does not take any responsibility for the Hirer's electrical system, or any associated equipment connected to it and should any damage occurring to the ANDREWS SYKES CLIMATE RENTAL Hire Plant which may be attributed to the Hirer's electrical system or associated connected equipment will be chargeable to the Hirer.

Unless otherwise modified herein, the ANDREWS SYKES CLIMATE RENTAL Standard Terms and Conditions of Hire are applicable to all quotations and Hire Contracts, a copy of which can be provided upon request.
